Proposed Development: To turn three doghouse dormers to one dormer with three windows, replace right rear window with an 8" longer window, replace chimney cap with a copper chimney cap, and replace sunroom windows with 12" longer

windows.

Gary Moore presented the proposal to convert dormers, lengthen windows, and replace chimney cap. Before-and-after renderings depicted all work to be done on the rear façade. Board members asked clarifying questions about design details but had no concerns. The Board noted that the Village Design Advisory Committee reviewed the application and also had no concerns.

Proposed Development: To install two signs and lights. One 12.5 sq ft sign affixed to the north elevation with one light and one 20 sq ft sign freestanding on

road frontage with one light on each side.

Ben Pauly presented the proposal for illuminated signs at Farmer and the Bell. Keri Cole arrived during the presentation. Ben Pauly described the two signs would be wood or steel, depending on cost, and would display the logo and name of the establishment. Staff assured the Board that the size of the signs and level of illumination were compliant with regulations. The Board noted that the Village Design Advisory Committee reviewed the application and also had no concerns.
