C. Citizen Comments – Three Minutes per participant

Byron Kelly spoke regarding the security cameras in the building that were recording without notification.

Nicholas Seldon commented on what he described as Woodstock's financial situation, criticizing spending. He raised concerns about the depletion of the village's general fund.

Roger Logan urged the Boards to finalize the Town manager's contract that evening.

Bill Boardman suggested that if the Manager's contract were to be renewed, it should be for no more than one year.

Eric Duffy clarified comments that the \$200,000 legal fees mentioned by a commenter, were split between Town and Village, with approximately \$75,000 for the Water company (approved by the Selectboard), \$30,000 for public records requests, \$30,000 for Community Development and Planning legal fees, and the remainder for a personnel issue.

D. Discussion

FY27 Budget

Eric Duffy provided an overview of the current budget projections:

- Town: 8.2% tax increase
- Village: 10.6% tax increase (potentially reduced to 9.9% if Trustees forfeit stipends)
- Sewer: 9.3% rate increase
- Water: approximately 30% increase

The discussion clarified that even after budgets are approved at Town/Village meetings, the actual tax rate could decrease if the Grand List increases in value. This would be determined closer to when tax bills are sent out in August/September.

Laura Powell raised a proposal for adding a code enforcement officer position within the Community Development and Planning office, which would need to be allocated across Village, Water, and Sewer budgets. She noted this position could potentially generate revenue through fines and fees, particularly related to Zoning compliance (\$200/day) and short-term rental violations (up to \$800/day).

Several board members expressed hesitation about a staff member at this point in the budget process, suggesting instead that current staff might reorganize their time to focus more on enforcement. It was noted that years ago, enforcement was accomplished with fewer staff members.

Eric Duffy clarified that current staff focus has been directed toward housing goals rather than code enforcement, based on board priorities.

Roger Logan commented that the boards should continue their approach rather than reallocating staff from areas like housing development work, and also suggested that in the next fiscal year, the boards should examine how the police force is organized and funded.
