#### **E. Letter From the Town Hall Staff**

A letter dated December 19, 2025, was read into the record from concerned members of Town Hall Staff. The letter detailed ongoing intimidating behavior by an individual known to the Boards that was affecting staff well-being and creating workplace safety concerns. The letter requested immediate attention, clear expectations for public conduct, review of safety measures, and guidance for staff on how to respond to future incidents.

Board members acknowledged the seriousness of the situation and expressed concern for staff's well-being. They noted that some physical changes had already been made to the building to address safety concerns, but more needed to be done while balancing public accessibility.

Eric Duffy shared that Woodstock has exceptional staff who are professional and passionate about their work, noting that they provide extraordinary service despite these challenges. He expressed concern about normalizing inappropriate behavior and the potential impact on staff retention.

Roger Logan and Al Alessi expressed support for the Boards and the Staff. Board members discussed potential approaches including:

- Establishing rules of procedure for public meetings
- Continuing conversations with Staff to understand their concerns
- Consulting with VLCT and other Towns that have faced similar issues
- Investigating security camera options


